In 2005, we took our system public so that anyone with a desire to succeed could learn and coach this complicated sport. For 100+ years, coaches have asked: "Why isn't wrestling broken down into a belt-system like Karate and BJJ do? Well, we did that in the late 90s when we started the nation's FIRST wrestling academy. With the Purler Wrestling online academy, the sport of wrestling is broken down into 4 parts: **Basics, Phase I, Phase II, and Phase III.**

**Gymnastics has LEVELS. Martial Arts has a BELT system. Wrestling has PHASES.**

#### **AFFORDABLE**

It is impossible for a coach to get his entire team of HS, MS, and youth kids to a summer camp, because it is difficult to ask a parent to write a \$500 check for the camp, send another \$200+ for travel, plus an extra \$200 for their son/daughter to have as spending money. \$1,000 for a camp is a lot to ask 70-90 parents to shell out, especially since a lot of your team is probably so heavily involved in other sports much of the year. With the PTC, you wrestler gets a full 5 day camp (or 2.5 day / 2 day) for around \$39 / day, and each gets a FREE \$200 online camp video program. Our camps are just about the only way to get ALL OF YOUR KIDS involved in the camp experience. Plus, with our camp, you are getting TRAINING, and not just MAT TIME!

We have held these camps in nearly every state except AK....so yes, no matter where you are we can make it happen.

#### **Pricing per wrestler**

Prices vary and all teams choose a different route, but the average cost based on just 40 wrestlers is \$39/day per wrestler for the 5-day PTC, and just \$47/day for the 2 – 2.5 day camp option. Of course, if you have 60-80 wrestlers, the price can be significantly less!

We suggest for your team, charging \$39 - \$47 / day (which is just \$6.50 / hour) and charging \$59/day for outsiders. We also suggest that you at least make the parents pay half, in case the booster club was wanting to

provide the camp. This way, on camp day you don't end up missing half of your team, which we have seen happen.

If you open the camp up to outsiders in order to provide the camp, and/or make money for the teams account, we suggest charging those wrestlers \$59 / day. Remember to mention that they do receive a \$200 streaming online wrestling camp video series so they basically can get almost ALL of their money back in this 24/7 video program.

Fundraiser option / tip- We also suggest that you get big support from your team, so that you know that 90% of the camp is paid for and can count on the rest of the enrollment that comes is as being full profit!!!

4. Private Small Group Camp – (\$3,950 + hotel) -This camp is 2.5-day format only and is not meant to be used as a fundraiser, and is for a MAXIMUM of 16 wrestlers. Camp designed for the parent who wants the camp, but is not one of the coaches, but has a handful of wrestling dads / moms who would gladly pay for the amazing camp, and want to 'learn from the best' so that they can help their kids, and get the full access to the online academy to boot. (\$3,950 + hotel) so \$98/day per wrestler, who gets the 2.5-day camp and the \$200 camp academy video series.

We cover the core of our system in these camps, and for the 5-day camp, we get through our entire program, which is called the 3 Position Camp at our summer camp. The best skills from the most common positions, plus a HUGE emphasis on becoming MASTER LEG RIDERS. Obviously, for the 2.5-day options, we cover about half of this format, and do a 'best of the best' approach. And for those who choose the 2-day PTC, we suggest that one full day is leg riding, while the second day is spend mastering the best of the best of the core skills.

**Hotel** – The host school is responsible for providing the hotel for the camp (starting the night before the camp and ending on the morning of the final day of camp. (EX – For a 2 day, Saturday & Sunday camp, hotel is needed for Friday and Saturday night. We cover ALL OTHER expenses including airfare, car rental, etc...

Our summer camps are held at our privately-owned 24,000 square foot training center on 10 full acres just 30 miles North of St. Louis, MO. Our camps have sold out most years for 16 years straight and have drawn wrestlers from as far away as Japan, Mexico, and all states including AK and HI.

#### **How to make this camp happen:**

1. Email [info@purlerwrestling.com](mailto:info@purlerwrestling.com) the dates you need and camp you would like us to do (2, 2.5, 5 day, or PSGC)
2. Get your team involved and have the parents respond and let you know that they want an affordable camp, and one with no travel expenses, and you will find that 80-90% will be on board.
3. Book the camp with the link on the site or this form.
4. Get the hotel room arranged and email that info to us.

5. Then the camp is set! The coaches and booster leaders need to make the decision, and get parents to say yes, then book the camp. I say this since I have found that all too often, we over-communicate and meeting ourselves to death, then it gets to be a job and falls apart. We will likely sell out most summers no matter what, but I don't want anyone to miss their best week(s) because this gets to be a process.
- EX- Parents, here's the camp....do you want a camp for \$42 / day and a \$200 amazing video program for free? Oh, I see we have 46 yesses! Great, the camp is set. All you who said yes have an invoice in your email click that link and pay us because we booked this amazing camp and we can't wait!! Boom!!! **Move fast my friends!!**

#### BENEFITS:

#### STAFF:

Only PURLER-TRAINED coaches do the camp instruction at our **PRIVATE TEAM CAMPS**. We send only ONE coach and if you have a lot of kids at your camp, you should arrange to have your coaches helping out at the camp.

Day 2 - Same- unless we need to change the schedule a bit in order to make a flight home. Hard wrestling times will vary depending upon the pace of the camp.

***NOTES - Session times for the 5-day camps are to be the same. However, the last day will end at 2:30 pm sharp so our coach can get to the airport and back home. Thank you***

#### AGE REQUIREMENTS:

We suggest getting your high school, middle school, and youth teams involved so you can pack the house! We suggest no one under age 7, but if you have a lot of little guys / girls, by all means feel free to do a modified camp (2 sessions / day) and have a coach help these kids during the drill time.

**Since we turn away many PTCs each summer, a \$500 non-refundable deposit is due immediately upon scheduling the workshop. For 5-day camps, the deposit is \$750.**
